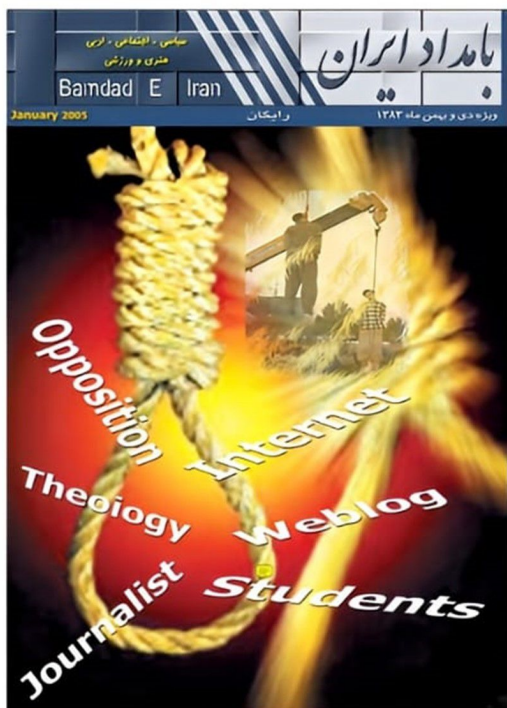

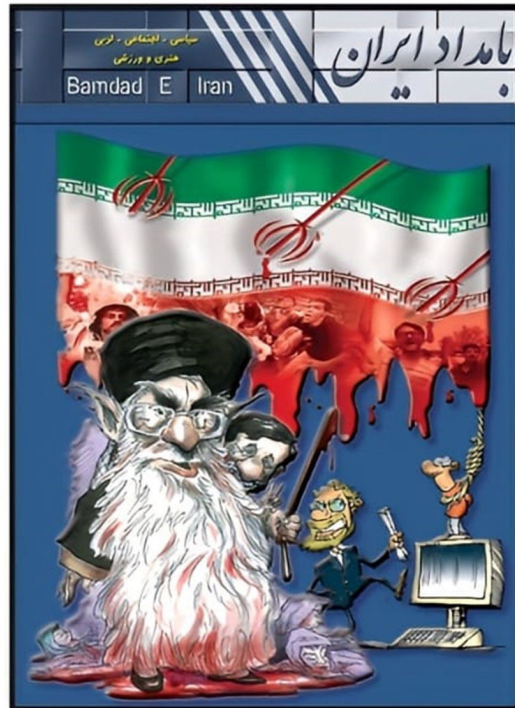

Dear Korosh Befroei,

Thank you for your correspondence of 26 February to Grant Shapps MP, regarding the actions of the Islamic Revolutionary Guard Corps (IRGC) and their impact on the UK. Your correspondence has been passed to the Foreign, Commonwealth and Development Office (FCDO) and the Ministerial and Treat Official Correspondence Team in the Foreign, Commonwealth and Development Office has been asked to reply.

We share your view that the behaviour of the Iranian regime, including the actions of the IRGC, poses a significant threat to the safety and security of the UK and our allies. The Home Secretary and Foreign Secretary work tirelessly together to actively disrupt Iranian threats that impact the safety and security of the UK and those who live there. The Foreign Secretary has made it abundantly clear directly to the Iranian regime that any threats orchestrated by Iran will not be tolerated.

The Home Office recently guided the National Security Act 2023 through to Royal Assent, which will provide a significant new toolkit in the fight against individuals working for state entities like the IRGC. The Act criminalises a wide range of hostile activities conducted by, for, or on behalf of foreign powers. For example, any person materially assisting a foreign intelligence service in their UK related activity would commit an offence under section 3 of the Act.

On 14th December 2023, the new Iran sanctions regime came into force, giving us new and enhanced powers to counter Iran's hostile and destabilising activities in the UK and around the world. We immediately used these new powers to make designations in respect of Iran's support for Hamas, PIJ and Lebanese Hizballah. On 29 January, the UK announced a second package targeting criminal groups responsible for conducting kidnaps and assassinations on behalf of Iran and an IRGC unit and officials responsible for planning and attempting an attack against UK-based journalists. Since protests began following the death of Mahsa Amini in September 2022, we have sanctioned 94 Iranian individuals or entities involved in human rights



violations. We have made at least 56 designations against IRGC-linked individuals and entities since October 2022.

Whilst the government keeps the list of proscribed organisations under review, we do not comment on whether a specific organisation is or is not being considered for proscription. The National Security Act 2023 has already implemented new measures to protect the British public, including new offences for espionage and foreign interference and tougher powers to arrest and detain people suspected of involvement in state threats.

The UK government, law enforcement and our international partners continue to work together to identify, deter and respond to threats from Iran. We will continue to take strong action against Iran while they threaten people in the UK and destabilise the Middle East.

Dear Mr. Shapps, while I am wishing you health and success in your humanitarian goals, according to your official statement on January 15, 2024 regarding "Possible British military conflict with Iran (Islamic Republic regime) and several other countries in the next five years", and based on common interests that we have defined in the manifesto of the UIP and the statements of the Coordination Council of the Government of Iran in Exile and, we would like to bring some information about our common enemy, Islamic Republic of Iran, to your attention, which can be of help in your important responsibility of defending the borders of the British Kingdom and its interests in the world.

1- In the past, we sent similar letters of criticism, suggestions and requests to the foreign ministries and the rest of the honorable governments of Mr. Major, Tony Blair and David Cameron, however we did not receive a convincing answer. We all understand that establishing diplomacy with Russian and Chinese-linked terrorists, this regime, will only benefit the UK's enemies, and adversely affects the long-term national interests of Britain. Of course, let's not forget that during the past years, the Islamic Republic has carried out extensive politicization in Britain and Europe, and unfortunately, letters of criticism, suggestions and requests, as well as our warnings related to the national security of the United Kingdom and the gaining of power by groups affiliated with the regime have been ignored.

Of course, our letters were not only ignored by the governments of the time. But we also witnessed strong adverse reactions. For example, we opened and tested the temporary government of Iran's in exile in an experimental but official way at the head office of the party and coordinating council in Chingford, London, to see the reaction of the British government and its affiliated intelligence agencies, so that if Lord Cameron's then government's opinion is favorable, to implement the second phase in a real way and with the participation of volunteer political activists. which unfortunately was nothing but the raid of police on the headquarters of our political party and the coordination council in London and the homes and arrest of the general secretary-supervisor of the council and his wife, which is evident in the news links can be found the reference page.

On the other hand, we witnessed giving more freedom and space to the terrorists of Quds Battalion of IRGC with different titles of asylum seeker, refugee, student, investor, elite immigrant, etc. Also, in books and magazines such as Middle East Who Is a Real Terrorist and Brothers in Arms in Britain, Europe and America, we had given the necessary warnings and documents regarding the future dangers of not dealing with the terrorist regime in Britain and Europe, which unfortunately Our humanitarian warnings were also ignored.

2- Our specific request from the Prime Minister, the Minister of Foreign Affairs, Intelligence Services outside the country's borders, and all other security services of the country is that in this unique time that the current defense minister, to come to the assistance of Mr. Shapps, who tries to cut the regime's ties and deal with the terrorists of the Islamic and help him in this the strategic war against terrorism by cutting hands of the fifth column of the Islamic Republic Regime in Britain. The terrorist regime, which has been given such a chance that inside Iran, it burned the British flag and the pictures of the Queen and the Prime Minister inside the occupied British embassy, and threatened our officials and members in British soil and our family in Iran.

We all know the fifth column of terrorists of the Islamic Republic in Britain. Terrorists or mercenaries who were apparently asylum seekers and then because of having funds and facilities in British soil, specifically in London, Birmingham, Manchester, Newcastle and Glasgow, started investing, money laundering and paying the salaries and benefits of their mercenaries with the cover of businesses, cultural and religious centers, and what is more disturbing is that while the police raided the offices and houses of the opposition of the Islamic Republic in London and the criminal courts were investigating and imprisoning Iranian political activists in Britain, the terrorists of the Islamic Republic received tens of millions of pounds from the British government in grants to centers that promoted hatred and terror against the British people under the name of Islamic or cultural centers. In the first step, our request is to announce the terrorist group of IRGC in the list of British terrorist groups and to confiscate their properties in the UK in order to increase the budget of the anti-terrorism units of MI5, Scotland Yard and the National Security Agencies. In addition, we request you to close down the Iranian regime's so called Islamic and cultural centers we mentioned earlier. In this way, the safety of good people of Britain as well as the real political activists and opposition groups who are the real victim of the Qods terror group could be significantly increased.

3- At the end, our proposal that guarantees Britain's victory over terrorism without getting involved in a foreign war that can have other unpredictable and very dangerous aspects for everyone. We all know that the best way to deal with the threats of a strong and unified enemy is first to unite and second is to try to disintegrate the terrorist allies from within.

Our win-win package for the success of Mr. Shapps and all of us in defense of the sovereignty and land of the Kingdom of Great Britain in the name of human beings are members of a whole, in creation of one essence and soul, Saadi and the Charter of Human Rights of Cyrus the Great and the United Nations, as well as compensating part of the help that the good people of Britain And the governments of the time have given us the permission to fight against the terrorist regime of the Islamic Republic in order to save our lives as follows:

- As stated, the attack of the police on the central political office of the UIP and the Coordination Council of the Provisional Government of Iran in Exile in Chingford, London, and the imprisonment of the Party's Secretary General and the head of the Coordination Council and his wife caused very heavy losses to the party's political endeavour and activities outside Iran were suspended and then slowed down. It is worth mentioning that in the party's manifesto submitted to the British Ministry of Interior, the party's rescue committee was mentioned to help the exposed members to reach a safe place, and the representative of the Ministry of Interior came to the court and announced that he has no complaint against me or the party.

You definitely know what ups and downs and risks there are in the political struggle to overthrow a terrorist regime. Our request to the prime minister and the relevant ministers is to **allocate a suitable budget in the form of grant for the reconstruction of the party's structure and to resume our activities against the Islamic Republic with strength.** Of course, this requested budget, provided that Prime Minister, Mr. Cameron and Mr. Shapps have serious plans to counter the invasion of the Islamic Republic, will be used to form, reorganize, and build an effective media to have a greater impact on the people inside Iran and in our effort to overthrow the regime. In fact, this grant will be considered as a kind of donation for the will of the oppressed people of Iran in their fight against terrorism and for the unity and formation of an effective united opposition group and the government of Iran in exile which, ultimately, will positively contribute to the national security of the United Kingdom.

Dear Korosh Befroei,

Thank you for your letter of 3 May to the Prime Minister about Iran. Your correspondence has been passed to the Foreign, Commonwealth and Development Office (FCDO) and the Ministerial and Treat Official Correspondence Team in the Foreign, Commonwealth and Development Office has been asked to reply.

We strongly condemn the death sentence of prominent and fearless artist Toomaj Salehi. Iran's deliberate attempts to silence dissenting voices are clear for all to see. We have called on Iran to release him with immediate effect.

We co-ordinated a joint statement with human rights ambassadors at the UN strongly condemning Toomaj's death sentence, re-iterating that he must be released, and drawing attention to the severe restrictions against freedom of expression in Iran.

The UK opposes the death penalty in all circumstances as a matter of principle. At the UN Third Committee last year, we co-sponsored the Iran human rights resolution, calling on Iran to issue a moratorium on executions.

We are committed to working alongside international partners to hold Iran to account, including through the UK Mission to the UN in Geneva.

We regularly raise human rights issues directly with Iran, through our channels here in London and through the British Embassy in Tehran. We will continue to do so.

We do not comment on any potential proscription decisions, which would undermine any future action. We recognise the threat the IRGC and have taken significant measures to counter it at home and around the world.

That includes sanctioning the Islamic Revolutionary Guards Corps in its entirety – meaning the organisational structures are sanctioned – and more than 400 Iranian individuals and entities, including dozens of IRGC commanders.

We are confident that we have all the tools we need to sanction, prosecute, and mitigate the threats from Iran.

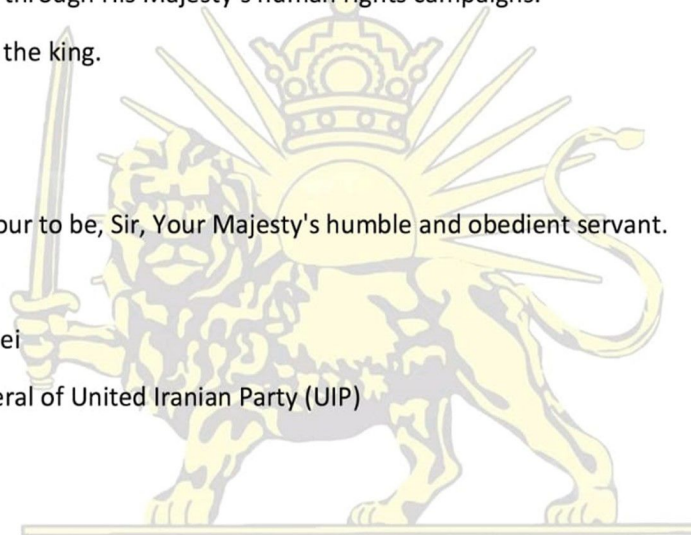

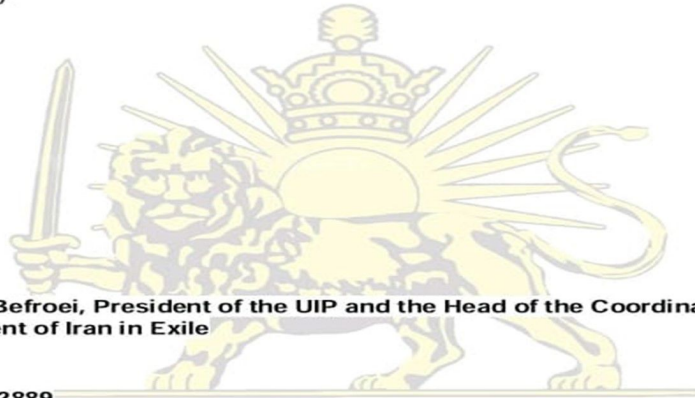

(New York) - Iranian authorities should promptly investigate the death of Amir Hossein Heshmat Saran, a 49-year-old prisoner at Gohardasht prison, and provide full disclosure about his medical care while in custody, Human Rights Watch said today. Saran died at the Rajayi Shahr public hospital in Karaj on March 6, 2009, after five years in detention. His is the third known death of a political prisoner at Gohardasht in the last three years.

"The government of Iran needs to conduct an impartial investigation into the suspicious death of Amir Hossein Heshmat Saran," said Joe Stork, deputy director of Human Rights Watch's Middle East division. "It should include his relatives in the process, make the results public, and hold accountable anyone found responsible for any mistreatment or medical negligence."

Saran's wife, Elaheh, told Human Rights Watch that on the morning of March 5, one of Saran's four cellmates in Section 2, cell 5 of Gohardasht prison called her, using a prison calling-card telephone, to say that Saran had taken ill the previous night and was taken to the prison health center. When she contacted the prison health center, she was told he had been transferred to nearby Rajayi Shahr Hospital's intensive care unit (ICU). She was able to visit him at the ICU for about 15 minutes. She said that he appeared to be in a coma "with just one eye open," his hands and feet shackled to the ICU bed. The whiteboard above his bed indicated that he was being hospitalized for "neurological illness."

The next morning, March 6, Elaheh Saran again went to the ICU to visit her husband. When she arrived, hospital personnel informed her that he had died. "The medical specialist who treated him told me he had brain hemorrhaging, and a lung infection which had spread throughout his body, that he should have been brought in sooner" she told Human Rights Watch. "They took him there when he was practically dead."

During a visit 10 days prior to his death, his wife said, his body appeared to be swollen, which he again attributed to lack of physical activity. He had fallen into a brief coma previously on February 26. After the first coma, the prison doctor took the unusual step of requiring a signature from Saran himself in order to administer an unidentified medicine in powder form.

Saran's lawyer, Mohammad Reza Faghihi, told Human Rights Watch that he and Saran's family immediately filed an official complaint with Branch 21 of the Karaj Appellate Court calling for an investigation into the suspicious nature of his death.

Authorities arrested Saran in 2004, and the Tehran Revolutionary Court sentenced him to 16 years in prison for his political activities, including participation in Iran Students' Day demonstrations, and for setting up a group called the National United Front (jebhe-yeh etehaad-e melli) which advocated for a more democratic Iran.

At the beginning of his detention, Saran wrote extensively about the prison conditions and, with the help of members of the National United Front, distributed this information to Iranian satellite channels in the United States as well as to websites.

Saran's wife said that he and his cellmates, Afshin Baymani, Behrooz Javidtehrani, and Karami Kheyraabadi, who were also political prisoners, had been attacked in prison, once by other prisoners and then "many times" later by prison guards, and had announced on the day before he was taken to the hospital that they would go on a hunger strike to protest bad prison conditions - including sanitary and health issues, lack of physical activity, and lack of proper lighting. "I heard from his friends that they were attacked by 30 prison guards that night in order to prevent them from going on hunger strike," she told Human Rights Watch.

Elaheh Saran told Human Rights Watch that throughout her husband's detention, she had been able to visit him every 15 days for 20 minutes and he never seemed ill until two months ago, when he complained that he had pain in his leg from a lack of physical activity. According to his lawyer, he did have a history of heart problems, though, which, coupled with information his family had received about the assaults he had suffered in prison, had led them to make repeated requests for medical leave for him over the years. Prison officials denied the requests.

Following Saran's death, his family received permission to take possession of his body for burial. They intended to bury him at a cemetery in their home town of Shahriar. At 6:30 a.m. on March 8, an ambulance driver from the mortuary where Saran's body was being held came to the Saran family home and said that the Ministry of Intelligence in Tehran had ordered that the body be moved to another mortuary some distance away.

"Three men from the Ministry of Intelligence later came to our home and told us that they would not give us his body because we made Saran's death too public on the internet and other places," Elaheh Saran told Human Rights Watch. "They said they could either bury him on their own anywhere or we could bury him ourselves, but we must tell all his political friends who have been visiting us not to come to the funeral." Eventually, the Saran family held a private funeral with immediate family members only and buried him in the Sakineh cemetery, where the body had been moved, a 40-minute drive from their hometown.

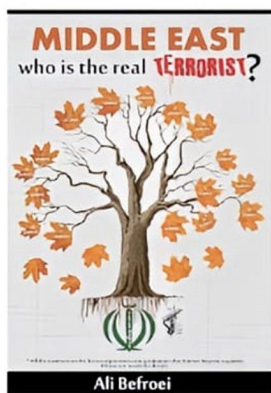
During Saran's five-year detention, the Ministry of Intelligence and Security repeatedly refused his family's requests for outside medical care, with the exception of a 15-day medical leave in September 2006. During Saran's absence, another political prisoner, Valiollah Faiz-Mahdavi, a former member of the Mojaheddin-e Khalgh organization (MKO) and Saran's cellmate, died after a nine-day hunger strike without medical attention (<http://www.hrw.org/en/news/2006/09/06/iran-new-death-political-prisoner-custody>). In October 2008, Abdolreza Rajabi, another political prisoner and former member of the MKO at Gohardasht, died unexpectedly, one day after being transferred from Tehran's Evin prison.

"There is clearly an alarming pattern of political prisoners dying in detention at Gohardasht prison," Stork said. "The Iranian government has an obligation to investigate these deaths and take measures to ensure that prisoners are not mistreated or denied medical attention."

A blogger being held in Evin prison, Omid Reza Mirsayafi, died on March 18 after lack of proper medical treatment, raising additional concerns about the treatment and medical access of political prisoners in Iran.

Under the UN Standard Minimum Rules for the Treatment of Prisoners, prisoners who require outside medical treatment should be transferred to specialized institutions or to civil hospitals.

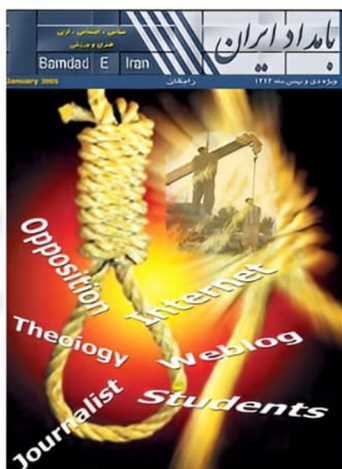

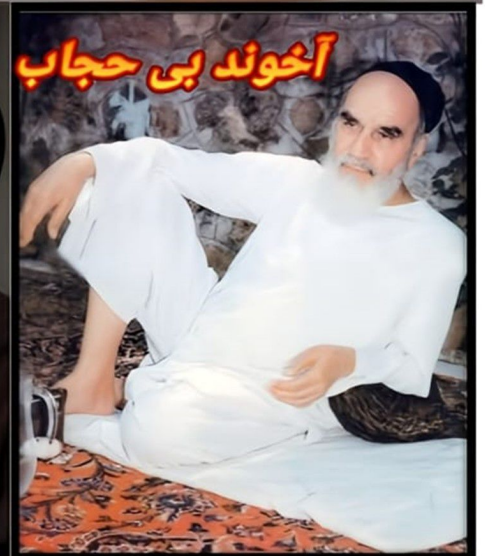
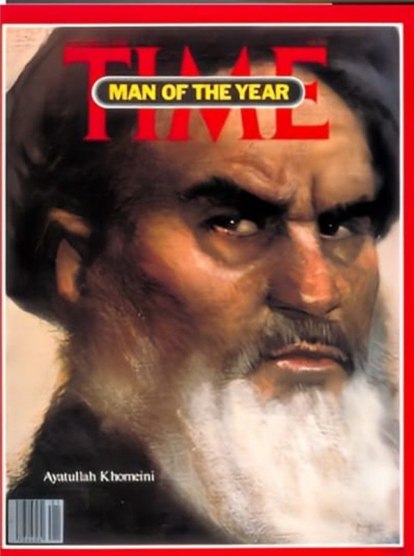

Dear Madam Ambassador,

United Iranian Party (UIP) is an independent opposition group of the Islamic Republic of Iran regime, which strives for the freedom of the Iranian civil society. We are writing to you on behalf of the Iranian people who have had their voices suppressed for 43 years since the terrorist regime of the Islamic Republic took power in 1979.

Iran once was a free country and a great ally of the west. It was becoming a global power and bringing peace and prosperity to the middle east and the world by focusing on regional growth and stability. However, since the religious dictatorship regime gained control, the whole region has always been in chaos. Peace and stability have been a missing piece in the lives of regional people and, to some extent, the entire world. We assume that you are well aware of the nature of the Islamic Republic. However, reviewing some of the critical issues with the regime can help us express our request more clearly.

The violation of human rights in Iran is to an extent that is impossible to mention in this letter. Thousands of people are arbitrarily detained, interrogated, tortured, and prosecuted yearly just for peacefully exercising their human rights. The regime's violent repression of dissidents, ill-treatment and torture of political prisoners, suppression of rights to freedom of expression, association and assembly, discrimination against minorities and religious groups, and hundreds of other human rights violations are well known by the international community. However, the lack of adequate response from the global community, mainly democratic countries like the UK and U.S., has convinced the regime's authorities that the state of human rights in Iran is of little importance to these countries. In fact, they are right since they have not seen any reasonable response from the western world for their massive human rights violations. Instead, the authorities and their families are welcomed to these countries with the massive wealth they acquired through embezzlement and corruption inside Iran and are allowed to live freely with complete impunity.

On the other hand, having access to considerable financial resources, the regime has been able to feed the international community a false narrative that facilitates the continuation of its repressive policies. There is a general perception among Iranian that there are various lobbying groups in foreign countries that act in the interest of the Islamic Republic regime. Iranian people believe that some of the Human rights organisations' employees are corrupted and act as state agents. There have been reports that high-tech companies like Facebook have been infiltrated by people sympathetic to the Islamic Republic regime, and the regime's proponents censor dissidents' contents.

It is utterly unacceptable that foreign countries have totally forgotten the state of human rights in Iran and allow the regime and its agents to take advantage of this opportunity to continue their policies. The regime's activities ultimately target and endanger western countries' national security interests. We are asking the U.S. government to see the reality of this brutal regime and take measures along with its allies to hold them accountable. There is no such a thing as reformist or extremist, and it is a terrorist state in its entirety, and they have done everything to prove this since they were in power.

However, it has been a steep learning curve for them, and they learned to avoid consequences, they must manipulate the international community through diplomatic negotiations and gestures. Nevertheless, the question is, how do you trust in or negotiate with a regime that uses its diplomats to carry explosives and plot to bomb an opposition group's rally (Assadollah Assadi)? When negotiating with Iranian diplomats, you should consider each one of them as another Asadi that will not hesitate to plot a terrorist attack on your country should they get the chance, as they have done numerous times in the past.

While the lobbying wing is trying hard to legitimise the regime's brutal behaviours and undermine the state of violation of human rights, the regime's terror activities are bold enough to attract enough attention to help western countries understand the reality of the Islamic State. Fundamentally, there is no difference between this regime and Isis, Al-Qaeda or other terrorist groups. The Islamic Republic is the main supporter of substate groups, including Hamas and Palestinian Islamic Jihad in Gaza, Hezbollah in Lebanon, Shiite militias in Iraq, and the Houthis in Yemen. IRGC (Islamic Revolutionary Guard Corps) was the main player in the slaughtering of Syria dissidents by Bashar al-Assad as the Qasem Soleimani is known as the Aleppo butcher. They take hostage innocent foreign visitors and travellers and demand money for their freedom. The money that finds its way to those groups and terrorist activities ultimately puts the U.S and western countries' national security interests at risk. They engage in drug trafficking, human trafficking, kidnapping, etc. Therefore, we are not just dealing with a religious dictatorship state, but rather with the biggest and wealthiest crime organisation in the world whose activities have destabilised the region and the world.

In this way, the voices of brave Iranian dissidents are heard, and they will force the government to change policies and hopefully, we can see the downfall of the mullah's regime in the near future.

Sooner or later, this regime will change, and the theocracy will end in Iran. However, if the U.S. government supports human rights in Iran, stays with people and helps them achieve their rights, it will become popular in the eyes of Iranians. This will facilitate building a good relationship after the fall of the Islamic Republic that can be beneficial to both countries and bring about peace and prosperity to the region and world.
